

In 2024, we plan to strengthen and streamline our programs to focus our efforts on the most critical and urgent challenges including:

- Protecting public lands to ensure our sensitive coastal habitat and resources are protected while continuing our joint water quality monitoring program at Point Reyes National Seashore;
- Advocating for coordinated and science-based sea level rise planning in Marin County and California, while amplifying and
 refining our climate crisis awareness work to build community resilience and protect our irreplaceable coastal resources;
- Ensuring fisheries and aquaculture are adaptively managed, sustainable and properly-sited, including participation in the Ocean Protection Council's aquaculture action plan public process, as well as monitoring new lease proposals as the newly created statewide public interest criteria are implemented;
- Safeguarding critical habitat in Marine Protected Areas (MPAs) by advocating for boundary expansions and
 protections to our local MPAs like Duxbury Reef and Drakes Estero from increasing climate and overuse threats while
 meeting California's 30x30 goals;
- Strengthening the Marin MPA Watch community science program through volunteer recruitment and trainings to collect human use data in Marin County's MPAs that helps inform statewide management;
- Formalizing our Duxbury Docent program in partnership with Marin County Parks and Open Space by creating an Advisory Committee and strengthening our volunteer presence on the reef to protect habitat and educate the visiting public;
- Expanding our legal and policy internship program into fellowships to further our legislative reach in advocating for the protection of the California Coastal Act and other bedrock environmental laws; and
- Advancing the Cleaner California Coast Initiative, a collaboration between three counties (Marin, Sonoma, and Mendocino) with Leave No Trace to increase public stewardship and lessen coastal pollution through a coordinated messaging campaign focused on education, training, and actions to reduce litter and increase protection and stewardship of our coast.

Join me in contributing to our cause by December 31st to help us launch into the new year with renewed energy and the capacity to proactively protect our coast. Please review how your donations are being put to work in the enclosed materials, and if possible, please consider increasing your charitable giving to help us meet rising inflation and operational costs.
