FOR HIS SERVICE ON THE FAIRFAX TOWN COUNCIL
AND MARIN COUNTY FLOOD ZONE NO. 9 ADVISORY BOARD

WHEREAS, David Weinsoff, having been first elected to serve on the Fairfax Town Council in 2005 and reelected twice thereafter in 2009 and 2013 will be retiring from the council in December 2017; and,

WHEREAS, David Weinsoff has served on the Marin County Flood Zone No. 9 Advisory Board since 2007 as Fairfax's representative, but he also has been keenly aware and focused on the broader, watershed-wide responsibilities of the Flood Zone No. 9 Advisory Board; and,

WHEREAS, David's interest and activity in local government and community service began well before entry into elected office with stints on the Fairfax Planning Commission, the Fairfax Open Space Committee, service on the boards of Marin Conservation League, Community Action Marin, and the Environmental Action Committee of West Marin; and,

WHEREAS, David's service in elected office has been infused by a passion for environmental protection and a commitment to community; and,

WHEREAS, as an attorney practicing in the area of environmental law, David has been relied on by colleagues and staff for his advice, counsel, and legal expertise on all matters environmental and beyond; and,

WHEREAS, David has been a consistent and persistent voice in prioritizing public safety for Fairfax and the entire Ross Valley serving as the Town's representative on the Ross Valley Fire Department Board and as the Fire Board Alternate on the Marin Emergency Radio Authority, as well as on the Flood Zone No. 9 Advisory Board; and,

WHEREAS, in every role he has served whether public office, non-profit board, community committee or commission, David has applied a critical mind, unique style, and added value to deliberations and decisions via insightful questioning, comment and the occasional verbal flourish; and,

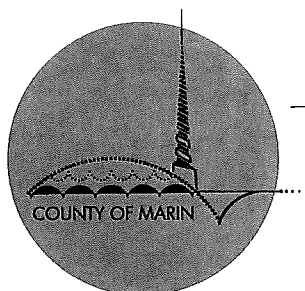
